Rent for space at the event is \$40 per 10' by 10' ft. area. Some fun events/activities may be fee-exempt. Please see the information sheet for specific information on set-up and closing times. **(Naches Lions no longer provide booths)**

If a vendor requires more plug-ins or higher amp service, an additional fee may apply. If electrical usage blows fuses or trips breakers, vendors will be disconnected. Portable generators that meet the Yakima County noise limitation standards are encouraged in the case of motor homes.

Y__ N__ Will you need water? The Naches Lions will attempt to supply water to booths that need it. **Vendors must provide their own hoses, at least one splitter, and buckets.**

Each vendor is responsible to keep their area clean. Garbage cans and a gray water disposal container are provided by the Naches Lions Club. The Gray water container MUST be used for Gray water.

Booth Applications with non-refundable rental fee, must be postmarked no later than Sept.4th. Applications may not be accepted after this date.

The Naches Lions Club welcomes you to Sportsman's Days, our community event. The Naches Lions Club has decided to purchase an Event Vendor Permit so you will not need to contact Naches City Hall about a permit. When deciding booth vendors and locations, our Lions Club prioritizes Naches organizations, school groups, and sports teams over others—our reasoning being that this event is presented once a year and it is some organizations only means of raising money. We are not limiting food vendor sales again this year. **Feel free to contact me to find out how many vendors will be selling the products you are considering.**

Early registration is key to getting booth location and other details arranged properly! Inappropriate or non-community related items will not be allowed. Safe, fun activities and events are encouraged! The Naches Lions reserve the right to limit items that create uncontrolled excessive litter on the grounds (potato guns, marshmallow guns, poppers, etc.)

- Food vendors must have Washington State Health Cards, and also a Health Permit from the Yakima County Health District (1210 Ahtanum Rd / 509-575-4040). The permit fee is \$10. Apply for your permit early, as you must have it one week prior to the event.
- Vendors will be allowed to set up Thursday noon-9pm, and Friday 9am-noon. **All booths/activities must be in place by noon Friday!** (FYI: Saturday morning, 7am, the parade and Car Show entries will start coming to sign-in for the parade starting at 10am.) **Please keep your booth open the entire run of the event, Friday 5pm to 10pm; Saturday 11am to 11pm, Sunday morning is take-down. Vendors should be out by noon.**
- Vehicles will not be allowed on Sportsman's Days Grounds from Friday noon to Sunday 8am. Only exceptions are Emergency Vehicles and Official Lions Club equipment. Vendors will be required to park their vehicles in a designated area ONLY, and to display per vehicle a dashboard pass provided by the Lions Club.
- The Naches Lions will attempt to supply 110V electricity and water as described on the application form.
- The Naches Lions will attempt to supply water to booths that need it. Vendors must provide their own hoses, at least one splitter, and buckets.
- **Each vendor is responsible to keep their area clean. Garbage cans and a gray water disposal container are provided by the Naches Lions Club**
- Grey water waste must be disposed of properly at the event in the container provided by the Lions Club.
- **Applications for Activity Booths:** Please be specific about your activity and the requirements needed; i.e. a speed pitching booth might only need a booth 10' wide, but might require a 20+' length.
- **ALL Vendors and Activity events are responsible for getting their start-up money prior to set-up.** If you forget, the Naches Bank, 22 E 2nd Street, is open Thurs. Sept. 7 until 5pm, and Friday Sept. 8 until 6pm.
- **Proposed Product(s)/Activities:** This year, vendors can sell food products of their choice. **NO DRUGS OR ALCOHOLIC BEVERAGES ARE ALLOWED.** **Please refrain from selling products not listed on your application.** Below is a list of food products sold by priority Naches organizations at Sportsman's Days. This may help you determine what you would like to bring.
